

Health Protocols

Updated December 1, 2020

The following guidelines have been put in place in accordance with OKC Fairgrounds requirements and the recommendation of the CDC and WHO regarding social distancing and public health. Attendees should review the current CDC and WHO guidelines prior to the event and refrain from attending the show if they have been in contact with anyone exhibiting COVID-19 symptoms within the last 14 days, have a fever or other symptoms, or are immune compromised.

An inherent risk of exposure to COVID-19 exists in any setting where people are present.

The 2021 Cattlemen's Congress Show will be closed to the general public. Participants, family, vendors and staff may attend in accordance with the health protocols contained herein and any applicable local, state or federal mandates.

If you contract COVID-19 while attending the Congress and test positive within 14 days of the event, please contact 405.235.0404 or at info@cattlemenscongress.com.

If you have a professional service provider (*i.e.*, trucking, sales managers, filters, veterinarians, etc.) attending to your cattle, they are required to review and adhere to these protocols, as well.

Exhibitors, Attendees and Arenas

- Exhibitors and attendees will be held responsible for providing and utilizing their own personal protective equipment, including but not limited to face protection, personal hand sanitizer, gloves, etc. Additional face coverings will be available for purchase, while supplies last.
- Face protection/face coverings are required per OKC Fairgrounds guidelines. Exhibitors and attendees are required to wear face protection/face coverings in all indoor areas, including but not limited to the arena, stands, show office, trade show, barn and bathrooms.
- Social-distancing outdoors is required at all times. No exceptions will be allowed.
- Daily temperature screenings are the responsibility of each individual at the show. Additional screenings with no-touch thermometers may be required for entry. Based on guidance from health authorities, anyone with a temperature of 100°F or above should not attend.
- Follow CDC guidance if symptoms develop.
- Exhibitors and attendees should not congregate in groups of larger than 10 people and must follow social-distancing guidelines.
- Put 6-feet between yourself and people who are not from your same household or household contact. Remember that some people without symptoms may be able to spread the virus.
- Exhibitors must keep at least 6-feet of space between each other at all times.
- Arena entrances/exits will be arranged so that exhibitors are not coming in close contact entering and exiting the arenas. Loitering is not permitted around the gate line up areas.
- Exhibitors shall maintain social-distancing guidelines at all times including but not limited to the lineup and show arenas.

- The Event is not open to the general public. Exhibitors are encouraged to limit the number of people in their group.
- Only one person is permitted to accompany an exhibitor in the lineup area.
- No foot traffic or spectators will be allowed at the in-gates. Participants that are not exhibiting an animal in the arena must go to the stands to watch the class, while wearing facial protection. If you do not want to wear face protection, the live webcast is available to be viewed outside of the facility.
- Those seated in the stands will be asked to leave two (2) vacant seats between each person from a separate household or household contact.
- Every other aisleway in the seating area will be blocked off by the facility for safe physical distancing.
- Exhibitors and attendees must deliver a signed COVID-19 Health Acknowledgment & Liability Waiver to the Show Office. The completed waiver is required to attend and participate at the event. The waiver is available at cattlemenscongress.com. Please print this waiver and bring it with you to the show.

Show Office

- Pre-entry and show related documents are only available online.
- Show Office capacity will be limited to one person per activity staffed front desk computer, plus one person in the waiting area for the next in line.
- Show Office will require at least 6-foot distancing for check-in areas and in locations where lines form.
- Show Office personnel will have a protective barrier separating them from exhibitors.
- Show Office will sanitize entry and exit points of office regularly. When possible, doors will be left open during check-in or periods of high traffic for air flow.
- Separate entrance/exit doors will be marked to minimize crossing of people.
- To minimize contact, communications will be made through announcements, text alerts and other contactless options.
- Stall and RV reservations will be coordinated by Congress prior to the event.

Staff and Other Areas

- Congress personnel, breed association representatives and OKC Fairgrounds staff are required to adhere to social-distancing protocols, daily temperature screenings and to wear face coverings to safeguard themselves and exhibitors to help mitigate the risk of spreading the virus.
- The announcer stands, microphones, judge tables and other show equipment will be sanitized with a disinfectant solution.
- Only Congress personnel and breed association representatives are allowed to access the announcer stands, paddock stands and judge areas.
- Signage will be placed around seating areas and throughout the facility to encourage safe physical distancing.

Enforcement

• Exhibitors, attendees and staff must abide by these social-distancing and health protocols; failure to follow protocols could result in removal from the OKC Fairgrounds and the forfeiture of fees. *Individuals will receive a warning for the first offense, mandatory discussion with show management for the second offense and potential removal from the facility for the third offense.*
