1. Exhibitors must have the original registration certificate issued by the American Angus Association available for inspection at the show for each animal or another current proof of ownership issued by the American Angus Association pedigree look up. Any animal, upon check-in, which does not have a legible permanent identification mark (ear tattoo marks, freeze-branded marks or hot-branded marks) corresponding to the permanent identification mark on the registration certificate, is ineligible to show. Once disqualified due to an incorrect or illegible permanent identification mark, animals cannot be re-tattooed and rechecked at the show.

2. Any female shown with a calf at side: the calf must be the cow's most recent natural calf, and the calf must be registered by check in and have proof of registration at check in.

3. Only one person at a time shall lead an animal into the show ring.

4. Exhibitors who participate in shows that are held by the American Angus Association are subject to the Association Rules as found in the Breeders Reference Guide of the Association. These rules are found in Part 2; Association Rules. The rules relating directly to the exhibition of Angus cattle are Part 2: Association Rules; Rule 800 Series; including Rule 800 - 810. These rules can be found at www.angus.org.

5. Altering the conformation and/or appearance of an animal for exhibition is prohibited. This includes the use of chin straps, covering of white skin, false tail heads (or use of any false hair), with the exception of false tail switches. The use of graphite, powders, hemp or other similar substances used externally are also prohibited. Other prohibited products include those used internally such as steroids, illegal or unlicensed pharmaceuticals or artificial filling. Any animal found to be in violation will be barred from showing.

6. At any show for which the American Angus Association participates, no exhibitors, individuals assisting exhibitors or member owners at such shows shall be allowed to use any coloring agents, on any animal exhibited. The Association may adopt and implement various tests designed to monitor this prohibition, including but not limited to a “white towel” or “white glove” test. No aerosol cans or other pressurized containers will be allowed in designated line up areas.

7. All animals exhibited are subject to DNA marker or blood type test to verify accuracy of parentage as covered under the Association Rules and for other testing as required by the individual show.

8. Authorized representatives of the Association have the authority to enforce the rules set forth herein as well as in the Association Rules, including the barring of a registered animal from a livestock show at which it is to be shown, if there are reasonable grounds to believe a violation has occurred.

BREEDING SHOW CLASSIFICATION:

Any classes listed in this classification, which exceed 15 head per class, should be broken into smaller classes. This should be accomplished by dividing the class as evenly as possible without splitting animals with the same birth date. Furthermore, the recommended number of head per class varies per show based on the number of head checked in. See recommendations below:

- Shows with less than 100 head: 8 head or less per class
- Shows with 100 – 200 head: 12 head or less per class
- Shows with more than 200 head: 15 head or less per class.

Class breaks will be at the discretion of the American Angus Association staff in attendance. If there are more than 30 head in a division, the division should be split into Division 1, 2, etc.

Calf must be the cow's most recent natural calf and be no more than 280 days of age on the day of the show. Any female that qualifies for female classes in the Association's Standard Classifications is not eligible to show in the cow/calf class.

BULL CLASSES

04 - Bulls born on or after January 1, 2022

GROUP CLASSES

01 - Get-of-Sire - four animals by one (1) sire, shown in the above classes, both sexes represented.

02 - Junior Get-of-Sire - three (3) animals by one (1) sire, both sexes represented. Entries must have been calved on or after May 1, 2023.

03 - Breeders Six Head - The exhibitor of the breeders six head must be breeder and first owner, identified by the same member code for the animals exhibited. Cattle owned by other exhibitors may be included provided the exhibitor of the breeder's six head is the breeder and first owner of the included animal(s). Animals must be exhibited in the individual classes. Cattle bred and owned by a junior member may be included if the exhibitor of the breeders six head is an individual or married couple and is the parent or legal guardian of the junior member.

SHOW: Friday, January 9, 8:30 am - PER

ANIMALS ENTERED IN THE FOLLOWING CLASSES MUST BE ENTERED AND SHOWN BY THE ORIGINAL BREEDER OR FIRST OWNER. All pens of bulls will be weighed prior to entering the ring, and average weights will be calculated. Exhibitors must designate alternate bulls at check-in to the American Angus Association Pen Superintendent. If an alternate is to be used, following check-in, it can only be done in the case of death, unsoundness or sickness. This must be approved by the Association superintendent. The decision of the superintendent is final. Bulls must be loose when exhibited. Registration numbers must be on the entry.

Entries to the Angus Association bull sale may be added from those carload and pen divisions that will add quality and strength to their entire sale, at the discretion of the American Angus Association staff and their sale manager(s).

Classes will be broken after arrival and processing according to the average age in days. Class designation is calculated on the average age of the bulls in the pen. Bulls may be no more than 30 days older or younger than the average age of the pen.

ANGUS PEN HEIFER SHOW

Exhibitors who participate in shows that accept premium monies contributed by the American Angus Association are subject to the Association Rules as found in the Breeders' Reference Guide of the Association. The rules relating directly with the exhibition of Angus cattle are in Part 2: Association Rules; Rule 800 Series; Including Rule 800-810. These rules can be found at www.angus.org.

Animals entered in the following classes must be entered and shown by the original breeder or first owner. All pens of heifers will be weighed prior to entering the ring and average weights will be calculated. Exhibitors must designate alternate heifers at check-in to the American Angus Association Pen Superintendent. If an alternate is to be used, following check-in, it can only be done in the case of death, unsoundness or sickness. This must be approved one hour before the time of the show, by the Association Superintendent. The decision of the superintendent is final. Heifers must be loose when exhibited. Registration numbers must be on entry form.

Classes will be broken after arrival and processing according to the average age in days. Class designation is calculated on the average age of the heifers in the pen. Heifers may be no more than 30 days older or younger than the average age of the pen.

ANGUS JUNIOR BREEDING HEIFER SHOW

1. To be eligible to compete per AAA rules, the entries must be recorded in the sole name of the junior exhibitor, and the issue date on the registration certificate must conform to the individual show's requirements regarding ownership. The AAA ownership applies to processed date, not sale date.
2. Exhibitors must have the original registration certificate issued by the American Angus Association available for inspection at the show for each animal or another current proof of ownership issued by the American Angus Association pedigree look-up. Any animal, upon check-in, which does not have a legible permanent identification mark (ear tattoo marks, freeze-branded marks or hot-branded marks) corresponding to the permanent identification mark on the registration certificate, is ineligible to show. Once disqualified due to an incorrect or illegible permanent identification mark, animals cannot be re-identified (tattooed/branded) and re-checked at the show.
3. Any female shown with a calf at side: the calf must be the cow's most recent natural calf, and the calf must be registered by check in and have the original registration certificate at check in.
4. Only one person at a time shall lead an animal into the show ring.
5. Exhibitors who participate in shows per the American Angus Association are subject to the Association Rules as found in the Breeders Reference Guide of the Association. These rules are found in Part 2: Association Rules. The rules relating directly with the exhibition of Angus cattle are Part 2: Association Rules; Rule 800 Series; including Rule 800 - 810. Exhibitors in the Bred and Owned Categories must be the breeder and the first and continuous owner of the animal entered. "Breeder" is defined as the recorded owner of the dam at the time of service. "First Owner" is defined as the recorded owner of the dam at the time the calf was born.

Two cow/calf classes will be offered

- 01 Cows Born January 1, 2023, through August 31, 2023
- 02 Cows Born December 31, 2022, or earlier

Calf must be the cow's most recent natural calf and be no more than 280 days of age on the day of the show (born March 30, 2025, or after). Any female that qualifies for female classes in the Association's Standard Classifications is not eligible to show in the cow/calf class.

ANGUS PHENOTYPE AND GENOTYPE SHOW

Show Wednesday, January 7, following the Super ROV Bull Show - JN

Animals entered in the PGS will be evaluated by a judge under a system that requires both genotypes and phenotypes to be considered. The results will be a composite score where the genotype (EPDs & \$Values) placing, and phenotype placings will be equally weighted at fifty percent.

In addition to the specific show rules of the American Angus Association Super ROV Show found on pages 1-3, the following rules apply specifically to the Phenotype and Genotype Show.

Requirements to enter:

1. All animals must have been genomic tested, with a DNA sample on file with AGI, by late entry deadline. The animal must be tested with Angus GS or HD50K Basic parentage testing does not qualify for this show.
2. Genomically Enhanced-EPDs are required at the time of check-in.
3. Any animal with interim EPDs or EPDs not enhanced with genomic results at time of check-in will not be allowed to show.

Show Categories:

1. Only females are allowed to enter with no specification on bred-and-owned versus owned. Champions will be selected in each division. Grand and Reserve Champion PGS Females will be awarded.
2. Entries will be listed in the catalog in order of age (youngest to oldest) and will be led into the showing in order of catalog number.
3. Classes will be made up after cattle have been checked-in at the show with no more than 15 head in any class and on a logical age break, not necessarily following formal American Angus Association classifications.
4. Division champions will be named in the female category as follows: Division I, Division II, Division III, Division IV.
